- GM Report
 - April 2025 snapshot:
 - 23% of sales were local; 35% organic.
 - Sold 1,687 \$5 dinners.
 - Sales growth YOY: 8.82%
 - Gained 14 new owners.
 - Owner sales accounted for nearly 41% of sales.
 - Four new LINC owners added.
 - Something for the board to be curious about: Does owner status increase loyalty/shopping frequency- is there a correlation between ownership and spend?
- B5 Consumer Report
 - B5 goal accomplished: launched customer satisfaction/experience survey.
 - o 2025 monthly customer count continues to grow.
 - Established new criteria for member/owner count. This decreased the overall number but makes the count more accurate. A focused campaign on engaging dormant/disengaged member/owners is ongoing.
 - Will likely phase out the comment card customer feedback method as online feedback methods are increasing in popularity.
